

“The Ball Thing” Terms and Conditions

General Terms and Conditions:

1. “The Ball Thing” competition (hereafter referred to as “the competition”) is a national competition organized by Funlab Pty Ltd, operating under the brand name of “Holey Moley”
2. While this is a cross-branded competition with Furphy operating as part of Lion Nathan Australia Pty Ltd, it is operating solely under the guidance and conduct of Funlab Pty Ltd
3. The competition is a random chance competition, with no skill inherent in the game.
4. There is no cost to enter the competition.
5. All customers at Holley Moley venues over the age of 18 year old are able provided a token on entry to place into a Ball dispenser. This randomly chooses a ball from the selection of balls in the dispenser, with some balls in the dispenser labelled as prize balls (with corresponding prizes listed below).
6. Not all balls available in ball dispensers correspond with a prize, with balls also non-prize balls (marked).
7. The prizes available are spread across the various states by breakdown, with a state by state list of prizes found in the specific terms and conditions for that state.
8. The competition dates are from September 23 at 8:00am AEST to October 27 2019 at 23:00 AEST, with the competition not available prior to or after these dates.
